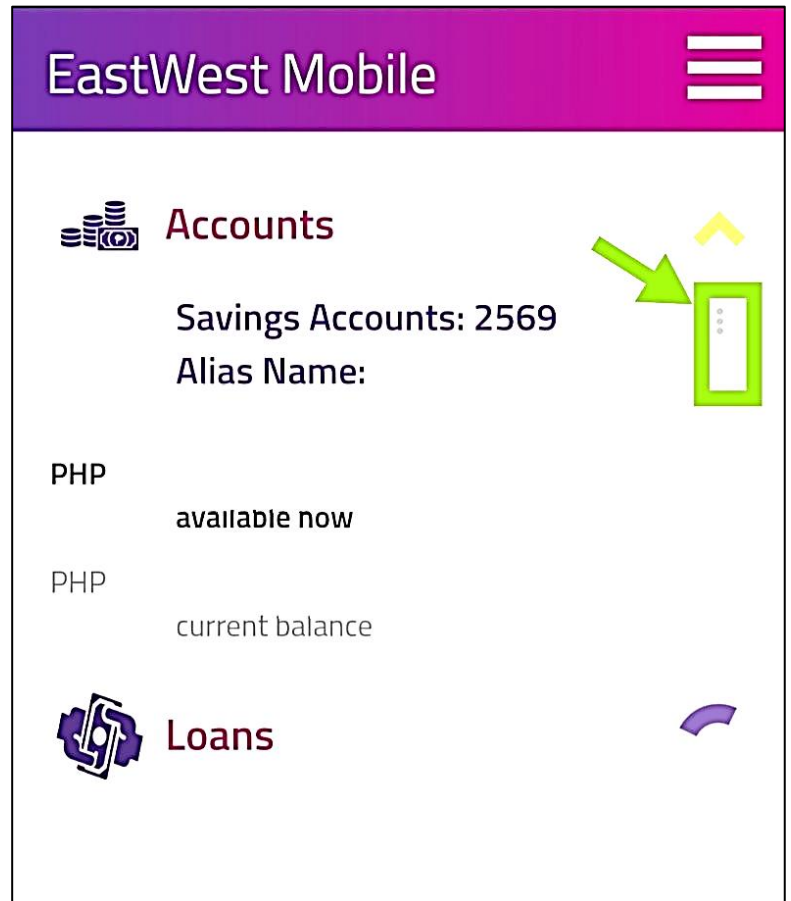

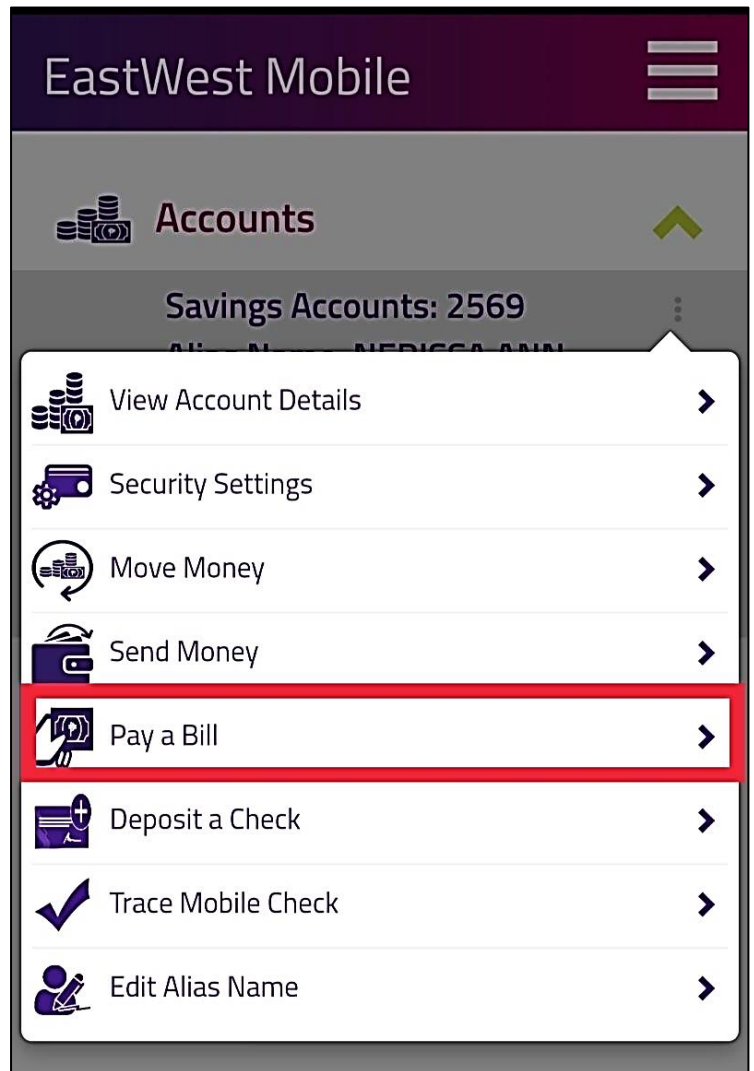
Launch the **East West Mobile App**, click on the three (3) buttons on the right side of your account number





Enter the **One-Time Password (OTP)** sent to your registered mobile number


